Woman Named First Education Secretary

WASHINGTON (AP) President Carter today chose Shirley M. Hufstedler, the first woman federal appeals judge, to be the first secretary of the Department of Education.

children. Carter, in a statement read to reporters by a spokesman, called Mrs. Hufstedler "one of the best minds in the country to fill the position." Deputy White House press

secretary Rex Granum said Mrs. Hufstedler, 54, met with Carter Monday afternoon, when the job offer was made and accepted. Her selection is subject to Senate confirmation. Mrs. Hufstedler is the third

woman named to a Cabinet post by Carter. The others are Commerce Secretary Juanita

Kreps and HEW Secretary Patricia Roberts Harris. The president, in his statement, said Mrs. Hufstedler "could take a new fresh look at the way we educate our

"She is deeply committed to the quality of education and enjoys my full confidence and support," Carter said. "I am certain she will be an outstanding secretary."

In a companion statement issued by the White House press office. Mrs. Hufstedler said she intended to carry out the administration's "long ... commitment to focusing attention on the real educational needs of our children." 'I expect to spend a great deal

of time as secretary of education listening to parents, teachers, students and other people who care about education in this nation," she said. "The first concern of this country in education must be

helping all students to learn." Granum, in announcing Carter's decision, left open the possibility that Mrs. Hufstedler would be considered for a position on the U.S. Supreme Court if a vacancy occurs while Carter is in office.

She is now on the Ninth Circuit Court of Appeals in California.

Granum said that the subject of a Supreme Court nomination came up when the judge conferred with Carter and that it was not precluded.

As education secretary, Mrs. Hufstedler, a liberal-tomoderate California Democrat. would oversee a department with a \$14 billion budget and about 17,000 employees. The post pays \$69,630 a year.

"I have intense concern about the quality of education for all Americans, particularly those in primary and secondary schools," she told the newspaper after her meeting with Carter. "But I don't have any specific ideas right now about the Department of Education because I simply don't know enough about the entire program."

Mrs. Hufstedler lives in Pasadena, Calif., with her husband, Seth M. Hufstedler, a prominent California attorney. She has one son, Steven.

Observers of the federal judiciary consider her liberal to moderate in her judicial philosophy; she had been mentioned as a prime candidate to be the first woman on the U.S. Supreme Court.

In 1969, President Lyndon B. Johnson appointed her to the 9th U.S. Circuit Court of Appeals, making her only the second woman to be named to a circuit court post and the first to the


Mrs. Hufstedler was born in Denver and graduated from the University of New Mexico in 1945 and the Stanford Law School in 1949, where she served on the Stanford Law Review. She began practicing law in 1950 and was appointed a Los Angeles County Superior Court judge in 1961,

In 1966, she was appointed to the California State Court of Appeals.

She serves as a trustee of the California Institute of Technology, Occidental College and the Aspen Institute for Humanistic Studies.

The legislation creating the Cabinet-level Education Department was signed into law by Carter on Oct. 17, setting in motion the bureaucratic machinery that will establish the department.

This will be the second Cabinet department established by Carter.



SERVE To Aid Handicapped Voters

Voting procedures which affect the visually impaired or disabled have been studied by the local SERVE organization (Serve Enrichment and Rehabilitation for the Visually Exceptional) with the purpose of assisting at the Nov. 6 election.

SERVE has been informed by the Union County Board of Elections that a visually impaired or disabled person is allowed to take a friend or relative into the voting booth to assist.

The alternative is to vote absentee ballot which may be secured by writing to the Board of Elections office in the Union County Courthouse and requesting a ballot or by going to the office in person.

The application requires the voter's name, voting residence and the reason for absence from the polls on election day. The ballot must then be completed and returned to the Board of Elections by 7:30 p.m., Nov. 6, or the ballot may be voted at the

office at the time of application. Acceptable reasons for using the absentee ballot are absence from the county on election day; hospitalization on election day; accident or unforeseen medical emergency; personal illness or physical disability; in jail for a misdemeanor or awaiting trial; religious ob-

servance; being an election official; or being 62 years of age or older

Before either of the two methods for voting listed above can be used the voter must be registered. **ŠERVE** recommends

checking to make sure of voter eligibility. If a person has not voted in the past two years, or has moved, he or she may not be registered. Registration for the coming Nov. 6 election is closed but registration reopens

for the spring primary election on Nov. 7.

After Death Of Korean President SEOUL, South Korea (AP) -Acting President Choi Kyu-hah named a new director of the Korean Central Intelligence Agency today in what was seen as the first major step to consolidate the government's position following the killing of President Park Chung-hee by

the KCIA's former head. The government also announced relaxation of the curfew and other martial law restrictions, as the fourth day since Park's death passed with no disturbances.

Choi appointed the vice army chief of staff, Lt. Gen. Lee Huisung, as acting KCIA chief to replace Kim Jae-kyu, under arrest for the assassination of Park Friday night. Sources said Choi's first Democratic Republican Party

appointment was an important move by Choi and the military leaders cooperating with him to take over the now-disorganized secret police organization, a mainstay of support for Park in suppressing dissent and political opposition during the late president's 18 years of autocratic rule.

The sources also said Choi and two other former prime ministers are leading contenders to succeed Park.

They said Choi, a veteran bureaucrat who was prime minister when Park was assassinated, and top military commanders are firmly in charge at the moment. Meanwhile, the political leadership of Park's



On Nov. 7, Sen. Edward M. Kennedy will announce in Boston that he will challenge President Carter for the nomination. On Dec. 4, Carter will announce he wants a second term.

The Kennedy candidacy advanced Monday when his brother-in-law, Stephen Smith, standing in front of a large "KENNEDY '80" banner, announced formation of the Kennedy for President Committee. He said be hoped "all citizens in this nation who share our belief that Sen. Kennedy should be the next president of the United States will join in the campaign we are beginning today.'

Smith said one reason Kennedy decided to run was that "he feels the real drift in this country and the sense of a lack of direction."

Asked about the Kennedy committee. White House press secretary Jody Powell said: "The American people will ultimately decide which candidate they wish to trust to lead them in the difficult times ahead."

Both the Kennedy and Carter camps made it clear they expect a tough battle that could remain undecided until bolloting begins at the Democratic National Convention in New York City in August. Neither camp expressed much faith in public opinion polls that show the senator leading the president amone Democrate.

"We're going to pay very little attention to the polls." said Smith.

Powell has said repeatedly that the president would fight for every delegate to the nominating convention.

"We look forward to an in-33 teresting campaign and to a

Smith, meeting with reporters, made it clear at the start that the campaign was on, that there was no longer any need for political charades to maintain that Kennedy was still making up his mind.

> "This is not an exploratory committee," Smith said. "It's a campaign committee."

While both sides are talking about leadership, there are other issues that will play major roles.


